Changes to Indirect Costs

From 1 December 2023, the underlying investment manager fees for private debt assets will be treated as 'Indirect Costs' rather than forming part of the Investment Management Fee. Based on the current allocations to private debt, the increase in Indirect Costs is expected to be approximately 0.01% per year. For more detail on fees and costs for each Fund, please refer to the table below.
