Important Notice

Mercer Emerging Markets Shares Fund

This Notice is to inform you that we have recently completed a review of the appointed investment managers for the Mercer Emerging Markets Shares Fund (ARSN: 126 405 838 APIR: MIN0037AU) (the **Fund**). As a result of this review, there are changes to the following effective 1 October 2025:

- Investment managers
- Buy and sell spreads.

Investment manager changes

We are responsible for establishing, implementing and monitoring the Fund's investment objective and strategy. As part of this process, we regularly review the appointed investment managers. Following a recent investment review, we have replaced Barrow, Hanley, Mewhinney & Strauss, LLC (Barrow Hanley) with First Sentier Investors RQI Pty Ltd (RQI Investors), as set out below.
